Sub: Regarding scrutiny & selection of online applications under Biju Yuva Vahini.

Madam/Sir,

This is regarding the new sub scheme 'Biju Yuva Vahini' under the scheme 'Biju Yuva Sashaktikaran Yojna' which is being implemented in all Gram Panchayats and Urban Local Bodies across the State.

Advertisement inviting online applications for enrolment of volunteers under Biju Yuva Vahini (BYV) was published in local dailies on 26.11.2017; the last date for which was 26.12.2017. The deadline for receiving online applications was subsequently revised to 10.01.2018, 20.01.2018 and 05.02.2018 which were duly advertised in the local dailies. There was no upper limit set for the number of online applications to be received under GPs/ULBs 05.02.2018. The general response for enrolment under Biju Yuva Vahini was encouraging in most of the GPs and ULBs. However in GPs and ULBs wherein adequate numbers of applications were not received as on 5th February 2018, it was decided to keep the online portal open for such GPs and ULBs, to receive applications till the number reaches 25 per GP/ward (in case of ULB).


Subsequently, a letter was issued by the department on 20/04/2018, wherein it was decided to allow fresh online applications from interested youth from all GPs and Wards (under ULBs) till the number of applications reaches 50. This is applicable for those GPs and Wards (under ULBs) where the number of applications received on or before 5th February 2018 was less than 50.

Since, selection of Biju Yuva Vahini members for each Panchayats/ULB to be done by Block/ULB level Committee requires verification of identity & age of online applicants, **the scrutiny of documents will be done for all volunteers who have applied online at any point of time i.e. those volunteers who have applied before 5th February 2018 as well as for fresh applicants.** For GPs/ULBs wherein the numbers of applications have exceeded more than 50 before 5/2/2018, it is still required by the Block/ ULB level committee to scrutinize the documents of all applicants for their selection as members of Biju Yuva Vahini.

The dates for scrutiny of documents of the applicants will be decided by the Block/ULB Level Committee as and when required based on the number of applications received. In case, where formation of BYVs and selection of office bearers have already been completed, new members will be inducted after scrutiny of documents by the Block/ULB Level Committee. In case where formation of BYVs and selection of office bearers have not been done, the date of 2nd meeting for the purpose may be decided by the Block/ULB Level Committee.


