Sub: Support Required in the Implementation of Biju Yuva Vahini scheme.

Sir,

The Odisha State Youth Policy (OSYP) 2013 was released on 7th April 2013 subsequent to which Department of Sports and Youth Services rolled out interventions like 'Integrated Youth Development Programme' and 'Biju Yuva Sashaktikaran Yojna' for the development of youth in the state.

State Youth Welfare Board now intends to prioritize and scale up the youth-led social action and community engagement activities envisaged under the policy by reaching out to youths all across Panchayats and ULBs. Accordingly, a new sub scheme 'Biju Yuva Vahini' has been designed under the ongoing flagship scheme Biju Yuva Sashaktikaran Yojna.

Under, Biju Yuva Vahini scheme, each Biju Yuva Vahini will undertake 12 social action campaigns as per the indicative themes and will conduct 5 sports tournaments/ meets in a year as mentioned in the operational guidelines (Enclosed).

State Youth Welfare Board has released funds amounting Rs.30,000/- per BYV formed in the first phase to PD, DRDA/DUDA and Municipal Commissioners. The funds released are meant to be utilized under two heads; a) Rs.15000/- for social actions and b.) Rs.15000/- for organisation of sports activities at GP/ULB level. The kind support of your Department is required in tagging of a Physical Education Teachers (PET) or Part time Physical Instructor teachers to each Biju Yuva Vahini for monitoring of sports equipment / activities at GP/ ULB level and countersignature of the Utilisation Certificates to be furnished by the BYVs.

You are therefore, requested to kindly impress upon the District Welfare Officers, who are a member of the District Level Committee under the scheme regarding the same for better monitoring & evaluation of the scheme.
