Subject: Regarding implementation of 'Biju Yuva Vahinis (BYV)' sub scheme under the Scheme of 'Biju Yuva Sashaktikaran Yojna'

Sir,

The approved Sub-Scheme of 'Biju Yuva Vahini' under the Scheme of 'Biju Yuva Sashaktikaran Yojna' covering all the GPs and ULBs of the State is currently under implementation. "Biju Yuva Vahini" is a priority scheme of the state government aimed at promoting volunteerism, leadership & instilling self confidence among the youth by involving them in awareness campaigns on important social issues, organising sports competitions across the state, etc. The programme is being implemented through a ULB Level Committee chaired by BDOs/EOs under the overall supervision of the District/ Municipal Corporation Level Committee (chired by the Collector/ Municipal Commissioner). A 3-member District Programme Management Unit (DPMU) has been set up in every district (2 DPMUs in case of district having more than 12 blocks) and a youth coordinator has been engaged for each ULB to assist the District & ULB level committees for implementation of the scheme. The successful implementation of the scheme requires frequent monitoring & supervision of the District Collectors/ Municipal Commissioners & PD, DUDAs.


Following are some of the action for successful implementation of the scheme:-

1. Formation of District/MC & ULB level committee as per the scheme guidelines.
2. Appointment of a nodal officer for each ULB/group of wards in case of MC, to oversee the BYV affairs.
3. Opening of separate scheme bank account for every ULB for transfer of funds from the department.
4. Formation of the Biju Yuva Vahinis: Ensuring timely conduct of 1st meeting (scrutiny of online applications) & 2nd meeting (notification of BYV members & facilitating selection of office bearers) of the BYVs as per guidelines.
5. Facilitating opening of "No Frills Bank Account" for the BYVs in coordination with the District Lead Bank.
6. Ensuring timely transfer of the funds from MC or PD, DRDA/DUDA →EOs →BYV

7. Ensuring the involvement & cooperation of the Ward level extension officers in the implementation of the scheme. Necessary assistance will be provided by the ULB level youth coordinator deployed by the Department of Sports & Youth Services.
8. Facilitating activities of the BYVs in convergence with various schemes of the government.
9. Review of the progress of the scheme in the district level monthly meeting of the Collectors & PD DUDAs.
10. Timely compilation & onward transmission of the Utilisation certificates by the Municipal Commissioners/ PD DUDAs to the Department of Sports & Youth Services.

You are therefore requested to review & supervise the activities & issue necessary instructions to the Executive Officers for smooth implementation of the scheme..
